



## **TERMS AND CONDITIONS**

### **TRAVEL DOCUMENTS**

U.S. Citizens must have a valid passport with at least six months validity remaining. Applies only for tours outside the United States.

### **DEPOSITS AND PAYMENT**

When signing up for the tour, a deposit of \$500 per person must be made. Nor-Am Tours LLC accepts check or cash. Make checks payable to Nor-Am Tours. After the deposit, payments must be made according to the payment plan for each tour.

### **RATES AND FARES**

Prices are based on the exchange rate of US Dollar and the currency in the destination country or countries at the time the tour is planned. If the exchange rate should drop significantly under the known exchange rate when the tour was planned, Nor-Am Tours LLC reserves the right to adjust the price of the tour. The price of the tour is also based on a minimum number of travelers in the group. If the number of travelers is less than the number mentioned for each tour, Nor-Am Tours LLC reserves the right to cancel the tour, or give the travelers and option of still doing the tour with a smaller group, but with a little higher price. In the rare event that any of this should occur, the travelers will be notified, and will be offered the possibility to either accept the higher tour price, or cancel the tour with no penalties.

### **CANCELLATION POLICY**

All cancellations must be submitted in writing. Email is accepted as writing. The following refunds will be made:

Cancellation more than 120 days (4 months) prior to departure:	100 % refund
Cancellation 120 – 90 days prior to departure:	75% refund
Cancellation 60 – 90 days prior to departure:	50 % refund
Less than 60 days prior to departure:	No refund

### **TOUR PRICE INCLUDES**

Services included in the tour price is listed for each tour, under the "Tour Includes"-section.

#### **Not included:**

Passport fees, all items of personal nature, beverages, meals not specified in the itinerary or items not included in the tour, luggage handling at airports, personal travel insurance, tips for drivers and guides.

### **DOCUMENTS**

Documents will be sent out at least two weeks prior to departure. No travel documents will be sent out until the final payment has been done.
